Subject: Alcohol Licensing Demerit Point System Updates

Background

Demerit points are connected to a City of Fond du Lac alcohol license and are governed by Section 400-7 of the Code of the City of Fond du Lac. Demerit points assist the City in making recommendations on possible suspensions or revocations of alcohol beverage license and seek to identify habitually troublesome liquor licensees who repeatedly violate state statues and/or City of Fond du Lac ordinances.

When a qualifying violation occurs (see list in Section 400-7(B)) at a licensed establishment, the City of Fond du Lac Police Department will notify the licensee that demerit points have been assessed. If a licensee accumulates the following points within a 12-18 month time period, the City may move forward with the following:

- 25 149 points = Warning
- 150 199 points = Warning or a suspension of the license for 10-90 days
- 200+ points = Warning or a suspension for the license for 10-90 days or license revocation

Any warning, suspension, revocation, or non-renewal of an alcohol license requires a hearing before the Alcohol Licensing Committee who will make a recommendation to City Council.

Proposed Changes

The City of Fond du Lac received a request to consider changes to Chapter 400 of the Code of the City of Fond du Lac regarding demerit points. The City met with the concerned tavern owner and discussed the current system in person and over the phone/email.

After reviewing the tavern owner's concerns and all relevant law, the City Attorney's Office and Police Department recommend the following changes to the demerit points system:

• Change demerit point amounts to better incentivize licensed establishments to promptly notify the Police Department of fights/disorderly conduct incidents.

- Better reference the Police Department's current practice of considering any mitigating circumstances when deciding to assess demerit points following a violation.
- Create a correction meeting process to assist licensed establishments in abating troublesome activity before running into demerit points trouble.
- Remove the points reduction course; the City does not currently have such a class in place.
- Change the lookback period for demerit points to be more uniform.

City staff recommends approval.

ORDINANCE NO. 3785

AN ORDINANCE AMENDING CHAPTER 400, INTOXICATING LIQUOR AND FERMENTED MALT BEVERAGES REGARDING THE DEMERIT POINT SYSTEM

The City Council of the City of Fond du Lac do ordain as follows; deleted items are shown with strikethrough and additions are underlined:

Section 1. That Chapter 400, Intoxicating Liquor and Fermented Malt Beverages; Section 7, Demerit point system., is hereby amended to read as follows:

§ 400-7 Demerit point system.

- **A.** System created. There is hereby established a point system for the purpose of guiding the Alcohol Licensing Committee in making recommendations on possible suspensions or revocations of alcohol beverage licenses. The number of demerit points shall will be assigned according to the type of violation. The system is intended to identify habitually troublesome liquor licensees who repeatedly violate state statutes and/or City of Fond du Lac ordinances and to take consistent action against such licensees.
- **B.** Assignment of points. There are hereby assigned the following demerit points for each type of violation:

- **C.** Method of determination. In determining the accumulated points, the date of the violation is used as the basis for assigning the demerit points per incident. A conviction for a violation is not necessary to assign points. That decision is made by the Chief of Police or his designee based on his analysis of the violation, including the presence of any mitigating circumstances such as notification of an incident by the licensee or cooperation with any lawful investigation.
- **D.** Point notification. The Police Department will notify the Alcohol Licensing Committee and the license holder of any incidents which result in the assessment of demerit points.
- E._Point reduction courses. During any demerit point counting period, a licensee may regain up to 50 demerit points for that period by successfully completing courses sanctioned for that purpose by the City of Fond du Lac Police Department. The number of demerit points returned for each successfully completed course shall also be determined by the Police Department.

Correction meeting.

- (1) Notice. Whenever the Chief of Police or designee determines that, on two or more occasions within a 12-month period, a licensee has violated any provision of this chapter or Wis. Stats. Chp. 125 in a manner resulting in enforcement action, the Chief may notify the licensee in writing. The notice shall contain the street address of or other description sufficient to identify the licensed premises, a description of the violations and enforcement actions that have occurred at the premises, and notice of the time and place at which the licensee is scheduled to meet with the Chief and the City Attorney as described in this section.
- (2) Any licensee receiving notice pursuant to subsection (E)(1) shall meet with the Chief of Police or designee and the City Attorney or designee at the date and time prescribed in the notice. The parties shall review the problems occurring at the licensed premises.

 Within ten days of this meeting, the licensee shall submit to the Chief and City Attorney an abatement plan to end the alcohol beverage-related violations and enforcement actions on the premises. The plan shall also specify the name, address, and telephone number of a person living within 60 miles of the property who can be contacted in the event of further police, fire, or inspection contact. Additionally, the plan shall include a signed statement from the licensee indicating their understanding that if they fail to comply with the abatement plan or to take the actions

discussed at the meeting, the City may move forward with efforts to revoke, suspend, or not renew their license. An abatement plan shall remain active for one year.

§ 400-8 Disciplinary procedures.

- A. Hearings and recommendations. The Alcohol Licensing Committee is hereby designated as the duly authorized committee that shall hold hearings as prescribed in § 125.12, Wis. Stats. As provided by law, after the hearing the Alcohol Licensing Committee shall submit a report to the City Council, including findings of fact, conclusions of law and a recommendation as to what action, if any, the City Council should take with respect to the license. In making its recommendation, the Committee shall consider, in addition to all other factors it deems relevant, the following guidelines. It is not intended that these guidelines limit the discretion of the Alcohol Licensing Committee, rather that they provide guidance in formulating a recommendation.
 - (1) For demerit points totaling 25 to 149 within a rolling twelvemonth period, a recommendation that the licensee be warned of the consequences of additional violations.
 - (2) For demerit points totaling 150 to 199 within a rolling twelvemonth period, a recommendation of a warning or a suspension of the license for a period of not less than 10 days and up to 90 days.
 - (3) For demerit points totaling 200 or more within a rolling twelve-month eighteen month period, a recommendation of a warning or a suspension of the license for a period of not less than 10 days and up to 90 days or of revocation of the license.
- **Section 3**. Any person violating the provisions of this Ordinance shall be subject to the penalty provided in Section 1-4 of the Code.
- <u>Section 4</u>. The appropriate City officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.

<u>Section 5</u>. All other ordinances and resolutions inconsistent with the provisions of this Ordinance are hereby repealed.

Section 6. This Ordinance shall take effect and be in force upon its passage and publication as provided by law.

On January 31, 2024, Assistant City Attorney Taylor Call, Fire Division Chief Jason Roberts and Police Captain Hahn, met with applicant Todd Lisowe, regarding his proposal for a Class B Beer and Class C Wine license at Ang and Eddies, 7 14th. St., Fond du Lac, WI.

The legal business name is TTAK LLC, DBA Ang and Eddies, where Mr. Lisowe and his wife Angela McCrory-Lisowe are the current owners of this restaurant. Todd and Angela Lisowe purchased the business with another couple in February of 2023. In July 2023, the Lisowe's took over full owner ownership by themselves.

Ang and Eddies is a restaurant that sells Chicago style pizza and sandwiches. They currently have approximately 10 tables and 24 seats, with a capacity of 40 people. During their ownership of the business, they received requests from customers to have beer with their meal. This request from customers was one of the basis for seeking the alcohol license.

Currently the business hours are Wednesday thru Saturday 4pm to 9pm and on Fridays they will open earlier for lunch at 11 am. He has no current plans on staying open later in the evening. Mr. Lisowe advises much of the business is carry out or delivery.

Mr. Lisowe currently works for a company in the food industry. He also has been involved with Ang and Eddies for approximately one year. Early in his career he also had experience as a bartender and in the restaurant/food service business setting.

Captain Hahn discussed with the applicant the City's expectations of being a license holder.

Background checks conducted on the applicant, both in-house and NCIC/CIB, indicate no prior criminal history that would preclude the issuance of the license request. The Police Department has no objections to the license request.

This location is currently a gas station/convenience store, which is Station 23. His proposal is to construct suite seating area which will share the same building as the convenience store/gas station. In this seating area they would sell beer and pizza. The beer would be kept locked in the suite area. Pub 23 will have the same operating hours as the gas station/convenience store, which is currently 600 AM to 1000 PM.

Dhillon does have approximately 20 years' experience in this field. He currently has 15 locations in Wisconsin that are Class A with 4 of them being Class B. He indicated that he has approximately 120 employees, 4 of which are general managers. He has owned this location, Station 23, since approximately 2019/2020 and is the current Agent for this location.

Captain Hahn discussed with the applicant the City's expectations of being a license holder.





Subject: Requirements for New Class "B" Licenses Connected to Another Licensed

Establishment Selling Alcohol

An alcohol license issued by a municipality "must contain sufficient detail to identify the specific areas where the alcohol beverages will be stored or sold or both" and a license which fails to do so does not satisfy the statutory requirement that a license must "particularly describe premises for which issued." *Wisconsin Dolls, LLC v. Town of Dell Prairie*.

Further, Wis. Stat. Sec. 125.32(3m) lays out the following:

(3m) Limitations on other business; Class "B" premises. No Class "B" license or permit may be granted for any premises where any other business is conducted in connection with the premises, except that this restriction does not apply if the premises for which the Class "B" license or permit is issued is connected to premises where other business is conducted by a secondary doorway that serves as a safety exit and is not the primary entrance to the Class "B" premises. No other business may be conducted on premises operating under a Class "B" license or permit. These restrictions do not apply to any of the following:

- (a) A hotel.
- (b) A restaurant, whether or not it is a part of or located in any mercantile establishment.
- (c) A combination grocery store and tavern.
- (d) A combination sporting goods store and tavern in towns, villages and 4th class cities
- (e) A combination novelty store and tavern.
- (f) A bowling center or recreation premises.
- (g) A club, society or lodge that has been in existence for 6 months or more prior to the date of filing application for the Class "B" license or permit.
- (h) A movie theater.
- (i) A painting studio.
- (j) Premises for which a temporary Class "B" license is issued under s. 125.26 (6) if the license is one of multiple licenses issued by the municipality to the same licensee for the same date and times, the licensee is the sponsor of an event held at multiple locations within the municipality on this date and at these

times, and an admission fee is charged for participation in the event and no additional fee is charged for service of alcohol at the event.

(k) Premises for which a Class "B" permit is issued under s. 125.27 (5).

Under the statute, a business applying for a Class "B" license cannot be connected to anther business, except that business "is connected to premises where other business is conducted by a secondary doorway that serves as a safety exit and is not the primary entrance to the Class "B" premises." The requirement that the two businesses can only share a secondary doorway that is intended to serve only as an emergency exit implies that the two businesses must be totally separate in the following ways:

- 1. The two businesses cannot be physically connected, other than by an emergency exit.
- 2. The two businesses must be completely walled off from one another.
- 3. Customers cannot easily go back and forth between the two businesses while consuming alcohol.
- 4. There ae separate outside entrances to each of the two businesses.
- 5. There are separate counters at each location that can specifically monitor the requirements of each separate license.

City staff recommends approval of Pub 23's Class' B" License at 919 East Johnson Street, Fond du Lac, WI., with the following conditions:

- 1. The Class "B" licensed establishment must have a completely separate premises description from all other licensed establishments and comply with all relevant provisions of Wis. Stat. Chp. 125 and the Code of the City of Fond du Lac. Separate premises must include the following:
 - a. The two businesses cannot permit cross access besides an emergency exit.
 - b. The two businesses must be completely walled off from one another.
 - c. Customers cannot easily go back and forth between the two businesses while consuming alcohol.
 - d. There ae separate outside entrances to each of the two businesses.
 - e. There are separate counters and staff at each location that can specifically monitor the requirements of each separate license.
- 2. The applicant must submit a site plan to the City of Fond du Lac Inspections Department showing said separate premises descriptions.
- 3. The property must pass all inspections with the City of Fond du Lac Inspections and Fire Departments and Fond du Lac County Health Department (when applicable), and obtain an occupancy permit.
