On January 31, 2024, Assistant City Attorney Taylor Call, Fire Division Chief Jason Roberts and Police Captain Hahn, met with applicant Todd Lisowe, regarding his proposal for a Class B Beer and Class C Wine license at Ang and Eddies, 7 14<sup>th</sup> St., Fond du Lac, WI.

The legal business name is TTAK LLC, DBA Ang and Eddies, where Mr. Lisowe and his wife Angela McCrory-Lisowe are the current owners of this restaurant. Todd and Angela Lisowe purchased the business with another couple in February of 2023. In July 2023, the Lisowe's took over full owner ownership by themselves.

Ang and Eddies is a restaurant that sells Chicago style pizza and sandwiches. They currently have approximately 10 tables and 24 seats, with a capacity of 40 people. During their ownership of the business, they received requests from customers to have beer with their meal. This request from customers was one of the basis for seeking the alcohol license.

Currently the business hours are Wednesday thru Saturday 4pm to 9pm and on Fridays they will open earlier for lunch at 11 am. He has no current plans on staying open later in the evening. Mr. Lisowe advises much of the business is carry out or delivery.

Mr. Lisowe currently works for a company in the food industry. He also has been involved with Ang and Eddies for approximately one year. Early in his career he also had experience as a bartender and in the restaurant/food service business setting.

Captain Hahn discussed with the applicant the City's expectations of being a license holder.

Background checks conducted on the applicant, both in-house and NCIC/CIB, indicate no prior criminal history that would preclude the issuance of the license request. The Police Department has no objections to the license request.

On February 13, 2024 Community Development Director Dyann Benson, Deputy City Attorney Alexandra Panagopoulos, Assistant City Attorney Taylor Call, City Clerk Margaret Hefter, Fire Division Chief Jason Roberts and Police Captain Anthony Hahn met with alcohol beverage license applicant Himmat Dhillon, regarding his proposal for a Class B Beer license at Pub 23, 919 E. Johnson St., Fond du Lac, WI.

This location is currently a gas station/convenience store, which is Station 23. His proposal is to construct suite seating area which will share the same building as the convenience store/gas station. In this seating area they would sell beer and pizza. The beer would be kept locked in the suite area. Pub 23 will have the same operating hours as the gas station/convenience store, which is currently 600 AM to 1000 PM.

Dhillon does have approximately 20 years' experience in this field. He currently has 15 locations in Wisconsin that are Class A with 4 of them being Class B. He indicated that he has approximately 120 employees, 4 of which are general managers. He has owned this location, Station 23, since approximately 2019/2020 and is the current Agent for this location.

Captain Hahn discussed with the applicant the City's expectations of being a license holder.

Subject: Requirements for New Class "B" Licenses Connected to Another Licensed Establishment Selling Alcohol

An alcohol license issued by a municipality "must contain sufficient detail to identify the specific areas where the alcohol beverages will be stored or sold or both" and a license which fails to do so does not satisfy the statutory requirement that a license must "particularly describe premises for which issued." *Wisconsin Dolls, LLC v. Town of Dell Prairie*.

Further, Wis. Stat. Sec. 125.32(3m) lays out the following:

**(3m)** Limitations on other business; Class "B" premises. No Class "B" license or permit may be granted for any premises where any other business is conducted in connection with the premises, **except that this restriction does not apply if the premises for which the Class "B" license or permit is issued is connected to premises where other business is conducted by a secondary doorway that serves as a safety exit and is not the primary entrance to the Class "B" premises.** No other business may be conducted on premises operating under a Class "B" license or permit. These restrictions do not apply to any of the following:

- (a) A hotel.
- (b) **A restaurant, whether or not it is a part of or located in any mercantile establishment.**
- (c) A combination grocery store and tavern.
- (d) A combination sporting goods store and tavern in towns, villages and 4th class cities.
- (e) A combination novelty store and tavern.
- (f) A bowling center or recreation premises.
- (g) A club, society or lodge that has been in existence for 6 months or more prior to the date of filing application for the Class "B" license or permit.
- (h) A movie theater.
- (i) A painting studio.
- (j) Premises for which a temporary Class "B" license is issued under s. 125.26 (6) if the license is one of multiple licenses issued by the municipality to the same licensee for the same date and times, the licensee is the sponsor of an event held at multiple locations within the municipality on this date and at these

times, and an admission fee is charged for participation in the event and no additional fee is charged for service of alcohol at the event.

(k) Premises for which a Class “B” permit is issued under s. 125.27 (5).

Under the statute, a business applying for a Class “B” license cannot be connected to another business, except that business “is connected to premises where other business is conducted by a secondary doorway that serves as a safety exit and is not the primary entrance to the Class “B” premises.” The requirement that the two businesses can only share a secondary doorway that is intended to serve only as an emergency exit implies that the two businesses must be totally separate in the following ways:


1. The two businesses cannot be physically connected, other than by an emergency exit.
2. The two businesses must be completely walled off from one another.
3. Customers cannot easily go back and forth between the two businesses while consuming alcohol.
4. There are separate outside entrances to each of the two businesses.
5. There are separate counters at each location that can specifically monitor the requirements of each separate license.

City staff recommends approval of Pub 23’s Class ‘B’ License at 919 East Johnson Street, Fond du Lac, WI., with the following conditions:



The City Council adopted Resolution No. 7625 creating Tax Incremental District Number Ten (TID 10) on August 25, 2004. The goal of the District was to attract private industrial, commercial and residential investment, thereby creating new jobs and expanding of the tax base. This would not have been accomplished without Tax Incremental Financing.

According to State Statutes and Tax Incremental Financing rules, a municipality must adopt a termination resolution at the earlier of a TID reaching its maximum life or when a TID receives tax increment payments that equal or exceed the project costs. In 2023, tax increment payments for TID 10 exceeded remaining project costs. Also of note for TID 10 is the Project Expenditure Period deadline was August 25, 2022. After this date, no further expenditures can be incurred or paid out of the TID.

State Statutes also provide the City an opportunity to extend a TID's life for up to one year and place a year of increment in a separate fund for Affordable Housing. The City's Affordable Housing Fund was created to improve the housing quality and affordability through the continued development of a detailed housing study, plan for needed investment in the housing stock, and assist in the development of affordable housing in accordance with sec. 66.1105(6)(g) of Wis. State Statutes. With the adoption of the Affordable Housing Extension resolution for TID 10, \$1,747,593.89 of increment will be transferred into the Affordable Housing Fund.


Due to strict deadlines imposed by the State of Wisconsin Department of Administration, both the extension resolution and termination resolution must be adopted by April 15, 2024. Both resolutions may be adopted at the same meeting as long as the extension resolution is adopted before the termination resolution.

Based upon the 2023 equalized value of the property, the termination of TID 10 will return the tax increment of \$89,073,100 of property value to the general property tax base of the City and the participating taxing jurisdictions effective January 1, 2024.

Upon adoption of the Affordable Housing Extension and Termination resolutions, notice will be filed with the Department of Revenue and a final audit of TID 10 will be scheduled.



## ORDINANCE NO. 3786

### AN ORDINANCE AMENDING CHAPTER 500-4 LOUDSPEAKERS AND AMPLIFYING SYSTEMS OF THE CODE OF THE CITY OF FOND DU LAC

The City Council of the City of Fond du Lac do ordain as follows; deleted items are shown with strikethrough and additions are underlined:

**Section 1.** That Chapter 500, Peace and Good Order; Section 4, Loudspeakers and amplifying systems., is hereby amended as follows:

#### **§ 500-4 Loudspeakers and amplifying systems.**

**B.** Permit application. Application for permit shall be filed with the City Clerk. The Clerk ~~shall present the application at the next regular or special session of the Council, which shall finally~~ will approve the issuance of the permit, subject to the provisions of this section and particularly the following restrictions:

**(1)** Sound tracks or loudspeakers transported from place to place shall operate on no street except Main Street and only between 11:45 a.m. and 1:00 p.m. and between 4:45 p.m. and 6:00 p.m. No operation shall be made on Sundays or legal holidays.

**(2)** Loudspeakers not transported and operated at one location shall not be operated between 10:30 p.m. and 10:00 a.m.

**(3)** No loudspeakinger system, whether movable or set up for one location, shall employ or use over ~~19 watts or eighty~~ eighty decibels of output. It is the intention of this provision that no amplifying device shall be operated at such volume that sound shall carry in excess of 100 feet to 150 feet from the point of broadcast.

**(4)** The Electrical Inspector shall have the right to inspect the loudspeakinger system whenever in use to determine the output.

**(5)** Sound wagons or any vehicle transporting any amplifying system shall keep moving with traffic while the system is being used and shall not stop or remain standing at any location on Main Street while using the system except as required by delay in movement of traffic.

**(6)** The ~~Council~~ City Clerk may cancel and declare any permit void where the speaking system is being used in violation of this section or of state or federal laws and the permit shall be returned to the City. Operation of such system after notice is given of cancellation of permit shall constitute a violation of this section.

**Section 2.** Any person violating the provisions of this Ordinance shall be subject to the penalty provided in Section 1-4 of the Code.

**Section 3.** The appropriate City officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.

**Section 4.** All other ordinances and resolutions inconsistent with the provisions of this Ordinance are hereby repealed.

**Section 5.** This Ordinance shall take effect and be in force upon its passage and publication as provided by law.

## Chapter 500. Peace and Good Order

### § 500-4. Loudspeakers and amplifying systems.

- A. Permit required. Except as otherwise provided, no person shall operate any loudspeaker or amplifying system so as to amplify and broadcast to the public either voice or recordings on or along the public streets or alleys or in any outdoor location in the City without obtaining a permit as provided for in this section. A special event or march/public assembly permit under Chapter **562** of the Code of the City of Fond du Lac may also be required.  
[Amended 2-13-2019 by Ord. No. 3684]
- B. Permit application. Application for permit shall be filed with the City Clerk. The Clerk shall present the application at the next regular or special session of the Council, which shall finally approve the issuance of the permit, subject to the provisions of this section and particularly the following restrictions:
- (1) Sound tracks or loudspeakers transported from place to place shall operate on no street except Main Street and only between 11:45 a.m. and 1:00 p.m. and between 4:45 p.m. and 6:00 p.m. No operation shall be made on Sundays or legal holidays.
  - (2) Loudspeakers not transported and operated at one location shall not be operated between 10:30 p.m. and 10:00 a.m.
  - (3) No loudspeaking system, whether movable or set up for one location, shall employ or use over 19 watts or eight decibels of output. It is the intention of this provision that no amplifying device shall be operated at such volume that sound shall carry in excess of 100 feet to 150 feet from the point of broadcast.
  - (4) The Electrical Inspector shall have the right to inspect the loudspeaking system whenever in use to determine the output.
  - (5) Sound wagons or any vehicle transporting any amplifying system shall keep moving with traffic while the system is being used and shall not stop or remain standing at any location on Main Street while using the system except as required by delay in movement of traffic.
  - (6) The Council may cancel and declare any permit void where the speaking system is being used in violation of this section or of state or federal laws and the permit shall be returned to the City. Operation of such system after notice is given of cancellation of permit shall constitute a violation of this section.
- C. Exceptions. This section does not apply to the use of loudspeaking or amplifying systems as follows:
- (1) Wholly within a permanent building.
  - (2) By a school when used in connection with educational purposes or when otherwise used noncommercially for any public address system at any athletic game or similar contest.
  - (3) Within the county fairgrounds which is bounded generally by Ninth Street, Martin Road, Fond du Lac Avenue and south City limits, when the use is by the Fond du Lac County Fair

Association at the annual Fond du Lac County Fair.

- (4) Within the public parks, provided permission is otherwise obtained from the City Manager.
  - (5) So-called wireless or radio transmission where the broadcast is not audible without the use of a radio or wireless receiving apparatus.
- D. Commercial advertising. No person shall operate or cause to be operated any loudspeaker or amplifying system on a truck or airplane for commercial sound advertising purposes in or over the City.
- E. Purpose of section. It is declared that the purpose of this section is solely to regulate the use of sound systems in the City which are covered by the provisions of this section and which have proven to be a public nuisance when operated without reasonable regulation. This section does not require any person to file with the City any statement of the public utterances to be made and no censorship of any kind shall be used in granting or revoking any permit, except as provided in Subsection **B** of this section.

**B.** Permit application. Application for permit shall be filed with the City Clerk. The Clerk ~~shall present the application at the next regular or special session of the Council, which shall finally~~ will approve the issuance of the permit, subject to the provisions of this section and particularly the following restrictions:

(1) Sound tracks or loudspeakers transported from place to place shall operate on no street except Main Street and only between 11:45 a.m. and 1:00 p.m. and between 4:45 p.m. and 6:00 p.m. No operation shall be made on Sundays or legal holidays.

(2) Loudspeakers not transported and operated at one location shall not be operated between 10:00 p.m. and 10:00 a.m.

(3) No loudspeaker system, whether movable or set up for one location, shall employ or use over ~~19 watts or eight~~ 80 decibels of output. It is the intention of this provision that no amplifying device shall be operated at such volume that sound shall carry in excess of 100 feet to 150 feet from the point of broadcast.

(4) The Electrical Inspector shall have the right to inspect the loudspeakinger system whenever in use to determine the output.

(5) Sound wagons or any vehicle transporting any amplifying system shall keep moving with traffic while the system is being used and shall not stop or remain standing at any location on Main Street while using the system except as required by delay in movement of traffic.

(6) The ~~Council~~ City Clerk may cancel and declare any permit void where the speaking system is being used in violation of this section or of state or federal laws and the permit shall be returned to the City. Operation of such system after notice is given of cancellation of permit shall constitute a violation of this section.

The former Beernuts Bar/Brickle Building at 183 South Main Street has a proposed redevelopment into a mixed-use project with residential units and commercial space along the Main Street frontage. The developer is proposing four (4) residential units on the second floor and up to four (4) residential units on the first floor. The Main Street portion of the building would offer commercial space.

This historic building, constructed in 1880, has been underutilized for a number of years. The closure of the former Beernuts and the building going onto the market creates a unique opportunity to support reinvestment in the south end of Main Street. The additional residential units will not only add to a much-needed inventory of housing options within the community, but within the downtown.

The City Council has authorized the submittal of a Community Development Investment (CDI) grant through the Wisconsin Economic Development Corporation (WEDC) for \$250,000. The CDI grant program provides funding to projects that create a significant, positive impact in downtown areas. The City will be applying for a \$250,000 CDI grant, the maximum grant amount available under the program, to support the approximate \$1.4 million renovation.

The estimated cost of the renovation is \$1,4 million. The proposed renovation will restore the historic façade but will also include roofing, windows and significant upgrades to the plumbing, electrical and HVAC. This property is currently assessed at \$142,700. Given the proposed work scope of the renovation, the addition of residential units along with the commercial space, the estimated assessment could increase to \$800,000 to \$900,000. This is a significant increase in value for a building within the downtown. The increase in value will also enhance the BID assessment to support the work of the Downtown Fond du Lac Partnership.

The City is proposing to further facilitate this project through a \$200,000 forgivable loan. The funds would be secured through a subordinate mortgage (meaning behind the primary lender(s)). The loan would be forgiven based upon the following conditions: \$1000 per year for any professional or service type commercial tenant or \$2,000 for any experience based commercial tenant (restaurants, retails, activity based businesses). Up to \$6000 per year per residential unit could be forgiven as long as there were no extended vacancy periods.

Reinvestment in downtown properties poses a financial challenge due to the nature of these historic buildings; the uncertainty of what will be found once renovations start and the financial cost of capital for commercial projects. In addition, the size of these projects attract small-scale developers that often have higher costs of capital than large commercial developers that can leverage other equity.

The ratio of City investment to long term benefits to the overall tax base as well to the downtown demonstrates a worthy partnership. City staff supports the investment in the project and will be bringing a resolution authorizing a development agreement for this project to the March 28<sup>th</sup> City Council meeting.
