**Re:** Possible Bike Projects in Lakeside Park West

Two separate bicycle groups have approached the City in their efforts to create new biking opportunities in Fond du Lac. One group involves mountain biking for youth in grades 6 through 12 and the other is a BMX group. I will note upfront that the former BMX site off N. Hickory Street is the proposed site of a new stormwater pond the City needs to construct in order to meet DNR requirements. Therefore, that property is not available to either group.

City staff have met with each group both separately and together in one meeting. The goals and facilities needed have some similarities but are mostly different so two separate locations are being reviewed, both in Lakeside Park West.

At the April APB, the initial concepts were presented to the board and the consensus was to invite both groups to present at the May meeting. Both of these groups will attend the May meeting and separately present their proposed projects. We will have one group go first and have the APB members discuss and ask questions and then we will move on to the other group. Attached are some rough concepts of the layouts of each.


