Re: Process for Budget Approval and Timeline

Timeline

- 1. <u>September 20, 2017</u>. Special Council meeting to review the budget. Any changes the Council wishes to make to the budget should be done at this meeting. The budget summary resulting from this meeting will be published with the public hearing notice. After this meeting, the budget will not be on the agenda until the public hearing.
- 2. October 25, 2017. Public Hearing on the budget.
- 3. November 8, 2017. Formal adoption of the 2018 City Budget, tax levy and the 2018-2022 Capital Improvement Plan.
- 4. <u>November 20, 2017</u>. The tax billing information will be provided to Fond du Lac County for preparation of the tax bills.

Budget Process

- The budget process is governed by Section 65.90, *Wis. Stats*. It requires a Public Hearing on the budget.
- During the Hearing, budget amendments may be made by majority vote.
- Significant changes to the budget at the Public Hearing, (the tax levy, appropriations or purpose), would require that the budget summary be republished.
- After the Budget Public Hearing process is complete, Section 65.90(5)(a), *Wis. Stats.* requires all changes to the budget to be by a two-thirds vote of the entire City Council membership.
