AN ORDINANCE AMENDING CHAPTERS 216 AND 488 OF THE CODE OF THE CITY OF FOND DU LAC TO ALLOW DOGS IN CITY PARKS

The City Council of the City of Fond du Lac do ordain as follows:

Section 1. That Chapter 216 Animals, Section 216-18 Prohibited areas for animals, is hereby amended to read as follows, with the language to be deleted shown as a strikethrough:

Any person owning keeping or in charge of any animal shall not permit the animal to be **in any park or** on any school grounds, except for school sponsored and authorized purposes, beaches, or cemeteries in the City at any time. **, except as otherwise provided in §488-9.** The provisions of this section shall not apply to seeing eye dogs used and accompanied by a blind person.

Section 2. That Chapter 488, Section 488-9 Animals, is hereby amended to read as follows, with the language to be deleted shown as a strikethrough:

A. No person shall bring any animal into any City park, except in:

- 1. Lakeside Park in an area bounded by Park Avenue, Harbor View Drive, Mohawk Avenue and the boathouses (the exercise area), and in other areas of Lakeside Park to the extent necessary when bringing an animal directly to or from a boat or directly to or from the exercise area.
- 2. Lakeside Park West in an area designated as a pet exercise area.
- 3. Conjunction with a permit granted by the City under and applicable provision of this chapter.
- A. Dogs in City parks. Dog owners may bring their leashed dogs into city parks with the following requirements and/or exceptions:
 1. Dogs shall not be allowed in or within 100 feet of the playground, petting zoo, or deer pen area at Lakeside Park.
 2. Dogs must be kept on leashes no longer than 6 feet.
- B. Dogs may be allowed in City parks during special events approved by the City, unless a special event applicant notifies the City in their special event application that dogs are prohibited at said event. The organizers of the special event must appropriately sign the event to let dog owners know that

dogs may not attend and have the responsibility of letting people know dogs may not attend their event.

- C. Anyone bringing an animal into a permitted area as described in Subsections A and B shall be responsible for such animal as described in § 216-17 of this Code. This section shall not apply to employees or agents of the City involved in the operation of the parks.
- D. This section shall not apply to a dog specifically trained to lead blind or deaf persons or to provide support for mobility-impaired persons.

E. Dogs in parks. This section grants permission for dogs on leashes with an adult handler in the following parks:

- **1. Colwert-Edwards Park**
- 2. Harborview Trail from Doty Street to Winnebago Drive
- 3. Hucks Bellvue Park
- 4. Lakeside Park West
- 5. Lallier Park
- 6. Ledgeview Corporate Center
- 7. McDermott Park
- 8. Paul Butzen Park
- 9. Plamore Park
- 10. Russell Park

Section 3. Any person violating the provisions of this Ordinance shall be subject to the penalty provided in § 1-4 of the Code.

Section 4. The appropriate City officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.

Section 5. All other ordinances and resolutions inconsistent with the provisions of this Ordinance are hereby repealed.

Section 6. This Ordinance shall take effect and be in force upon its passage and publication as provided by law.

Review

Last year the City Council voted to allow dogs in selected City Parks. As part of that policy change, Council asked to review the issue after one year. (A copy of the prior 2016 memo that discussed this issue is attached for reference.)

Analysis

A review of police records indicates that this change did not increase their calls to City Parks for dog complaints. The City Parks department did report several instances where dog owners approached the Petting Zoo and were reluctant to leave. Other than those instances, the park department did not have greater problems than previous years.

Last year the Advisory Park surveyed local residents and found some local dog owners expressed an interest in being able to enjoy city parks with their dogs. Other local residents have expressed their reluctance to have dogs in City parks.

The current ordinance strikes a balance between dog owners and other citizens. Dogs are allowed in some parks, but prohibited from other parks.

In general, City staff is pleased with the ordinance and how it has worked out and does not recommend any changes

Issue

Does City Council wish to lift the prohibition against having dogs in City Parks?

<u>If Council decides</u> to keep the status quo, they should make a motion to deny Ordinance 3611. If Council wants to allow dogs in some parks, they should make a motion to approve Ordinance 3611.

Analysis

Staff toured various City parks and looked at how the sidewalks and trails were laid out within the parks and where the sidewalks ran close to playgrounds and park structures. The physical configuration of some of the parks makes allowing dogs only on trails difficult. It appeared at some of the parks that dog owners would be able to walk their dogs halfway into the park, but then have to turn around and walk back out, to avoid getting too close to a park shelter or playground. It would also be more difficult for police driving by to be able to tell if a dog owner was complying with the ordinance without getting out and approaching the dog owner.

Based on the above, Staff has drafted a proposed ordinance. Ordinance 3611 is based on the staff tour, where we realized that some trails run right into the structures and equipment that Council has stated it doesn't want dogs near. The language in 3611 allows for the easy addition of more parks, if the ordinance change is well received by the citizens of Fond du Lac. An important consideration is ease of enforcement. In order for any change to be successful, it needs to be easily understood and readily enforceable.

Background

City Council member Brian Kolstad was approached by some citizens asking him to change our current regulations that prohibit dogs in City Parks. Staff has Deborah S. R. Hoffmann, City Attorney/Director of Human Resources August 4, 2016 Re: Dogs in Parks Ordinance Page 2

researched the current ordinances on dogs; some are attached. Currently, dogs are allowed on City trails and in two dog parks.

The Advisory Park Board has discussed this issue, but did not agree upon any changes. They surveyed local residents and found some local dog owners expressed an interest in being able to enjoy city parks with their dogs. Other local residents have expressed their reluctance to have dogs in City parks.

At their meetings on May 11th and July 13th, City Council discussed the idea of allowing dogs in all City parks that have sidewalks or trails, with the additional restrictions that the dogs must be on a leash and must stay on the trail or sidewalk, but stay 20 feet away from playgrounds and other park structures. Council also discussed imposing a fee or requesting a voluntary donation. Council did not specifically decide at that meeting if they wanted to amend the current ordinances that prohibit dogs in parks.

Options

<u>If Council decides</u> they do want to amend the ordinance and allow dogs in parks, Staff would like to make the following recommendations:

- 1. Staff recommends Ordinance 3611. It designates a list of City parks where dogs on leashes are permitted throughout the park. These parks would have signs that indicate dogs on leashes are permitted.
- 2. A map that shows the proposed parks is attached. We propose a graduated approach. We would begin with the parks outlined in dark green. (See 3611) The dark green parks group includes: <u>Colwert-Edward Park, Hucks Bellevue Park, Lallier Park, Ledgeview Corporate Center, McDermott Park, Paul Butzen Park, Plamore Park and Russell Park</u>. If all goes well, we could add the other parks that are currently shown in light green. We would not recommend allowing dogs in the parks outlined in red.
- 3. If Council would like to pursue an ordinance that allows dogs on more park paths, we would suggest further staff study and that we bring that concept back to you for further consideration before the end of the year.
- 4. If 3611 is passed, we would suggest checking back on this issue in one year to see how the experience has been and then determining if additional parks should be added or subtracted.

I want to thank all the various staff people who have worked on this issue and collaborated on this recommendation. We are open to additional input and to adapting to fit the needs of the community.

ORDINANCE NO. 3611 (As Amended)

AN ORDINANCE AMENDING CHAPTER 488 PARKS AND RECREATION, ANIMALS

THEREFORE, the City Council of the City of Fond du Lac do ordain as follows:

Section 1. That Chapter 488, Parks and Recreation, Section 488-9., Animals, is hereby amended as follows:

Add Thereto:

- D. Dogs in Parks. This Section grants permission for dogs on leashes with an adult handler to be in the following parks:
 - (1) Colwert-Edward Park
 - (2) Harborview Trail from Doty Street to Winnebago Drive
 - (3) Hucks Bellevue Park
 - (4) Lakeside Park West
 - (5) Lallier Park
 - (6) Ledgeview Corporate Center
 - (7) McDermott Park
 - (8) Paul Butzen Park
 - (9) Plamore Park
 - (10) Russell Park

Section 2. Any person violating the provisions of this Ordinance shall be subject to the penalty provided in Section 1-4 of the Code.

<u>Section 3</u>. The appropriate City officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.

Section 4. All other ordinances and resolutions inconsistent with the provisions of this Ordinance are hereby repealed.

Section 5. This Ordinance shall take effect and be in force upon its passage and publication as provided by law.

Chapter 488. Parks and Recreation

§ 488-9. Animals.

- A. No person shall bring any animal into any City park, except in:

- C. This section shall not apply to a dog specially trained to lead blind or deaf persons or to provide support for mobility-impaired persons. [Added 4-24-2014 by Ord. No. 3544]
- Dogs in parks. This section grants permission for dogs on leashes with an adult handler to be in the following parks: [Added 8-10-2016 by Ord. No. 3611]
 - (1) Colwert-Edward Park.
 - (2) Harborview Trail from Doty Street to Winnebago Drive.
 - (3) Hucks Bellevue Park.
 - (4) Lakeside Park West.
 - (5) Lallier Park.
 - (6) Ledgeview Corporate Center.
 - (7) McDermott Park.
 - (8) Paul Butzen Park.
 - (9) Plamore Park.
 - (10) Russell Park.
