RESOLUTION NO. 9162

A RESOLUTION WAIVING THE PROHIBITION AGAINST POSSESSION OF ALCOHOLIC BEVERAGES ON SPECIFIED PUBLIC WAYS FOR THE STURGEON SPECTACULAR FESTIVAL – FEBRUARY 7, 2025 TO FEBRUARY 9, 2025

WHEREAS, Fond du Lac Festivals will be hosting the Wisconsin Snow Sculpture Contest as part of the Sturgeon Spectacular Festival in downtown Fond du Lac; and

WHEREAS, Section 400-15, of the Code of the City of Fond du Lac, Wisconsin, allows the City Council to grant permission to waive the prohibition against public consumption of alcoholic beverages in City streets; and

WHEREAS, Thelma and Fond du Lac Festivals request a waiver of the prohibition against public consumption on Sheboygan Street between Marr Street and Main Street, as well as additional space half a block to the North of Sheboygan Street and half a block to the South of Sheboygan Street, on the following days and between the following hours:

Friday, February 7 th , 2025	from 5:00 p.m. to 9:00 p.m.
Saturday, February 8 th , 2025	from 10:00 a.m. to 9:00 p.m.
Sunday, February 9 th , 2025	from 10:00 a.m. to 4:00 p.m.

WHEREAS, the above-described waiver for Sturgeon Spectacular event is contingent upon Fond du Lac Festivals obtaining a Special Event permit for the event pursuant to Chapter 562 of the Code of the City of Fond du Lac and complying with all regulations contained within and related to Chapter 562 for Special Events.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Fond du Lac that the prohibition against public consumption of alcoholic beverages in City streets for the dates and hours listed above are hereby waived and contingent upon Fond du Lac Festivals obtaining a Special Event permit for the event pursuant to Chapter 562 of the Code of the City of Fond du Lac and complying with all regulations contained within and related to Chapter 562 for Special Events.

BE IT FURTHER RESOLVED that notwithstanding anything in this Resolution, no glass containers or carry-ins are permitted in the described

street areas, meaning that the prohibition contained in Code Section 400-15., shall continue to apply to glass containers and carry-ins.

BE IT FURTHER RESOLVED that proper City officials and/or City staff are hereby authorized and directed to take any necessary actions in furtherance hereof and in support of such events.

Dear Fond du Lac City Council,

From Friday February 7th to Sunday February 9th, 2024, Thelma Sadoff Center for the Arts (THELMA) will be a site for Sturgeon Spectacular events on Sheboygan Street between Marr Street and Main Street. FDL Festivals has requested the city of Fond du Lac to allow Sheboygan Street to be closed from Marr Street to Main Street and some additional space to the North and South on Portland St. (The additional space on Portland St. would be new to our extension of premises ask this year).

THELMA is requesting the City of Fond du Lac suspend the ordinance that forbids the consumption of alcohol in public from 5:00 PM until 9:00 PM on Friday, February 7th, from 10:00 AM to 9:00 PM on Saturday, February 8th, and from 10:00 AM to 4:00 PM on Sunday, February 9th. The extension of premises that we are requesting would follow FDL Festival's submitted site map: the sidewalk and street of Sheboygan St from Marr St to Main St, as well as Portland St as the map indicates (approximately half a block to the North of Sheboygan St. and half a block south of Sheboygan St). THELMA will help provide signage indicating that alcoholic beverages are not to be brought outside of the perimeter and beverages will only be provided in paper and plastic cups.

Beginning immediately after the conclusion of the event, THELMA will clean the area and remove all debris created by the events. THELMA will cease to allow guests to bring their beverages outside of the facility at 3:00 PM the last day of the event to facilitate the expedited clean-up of the venue area.



RESOLUTION NO. 9163

INITIAL RESOLUTION REGARDING TAXABLE INDUSTRIAL DEVELOPMENT REVENUE BOND FINANCING FOR 1125 EAST JOHNSON, LLC AND N 6663 ROLLING MEADOWS, LLC PROJECT

WHEREAS, Section 66.1103 of the Wisconsin Statutes (the "Act") authorizes the City of Fond du Lac, Wisconsin (the "City"), to authorize the issuance and sale of bonds by the City to construct, equip, reequip, acquire by gift, lease or purchase, install, reconstruct, rebuild, rehabilitate, improve, supplement, replace, maintain, repair, enlarge, extend or remodel industrial projects in the City; and

WHEREAS, Section 66.1103(3)(f) provides that a municipality also may finance an industrial project which is located entirely outside the geographic limits of the municipality, but only if the revenue agreement for the project also relates to another project of the same eligible participant, part of which is located within the geographic limits of the municipality; and

WHEREAS, 1125 East Johnson, LLC, a Wisconsin limited liability company, and N 6663 Rolling Meadows, LLC, a Wisconsin limited liability company, and/or a related entity, and/or an entity to be formed (individually and collectively, jointly and severally, the "Borrower"), desires to complete a multijurisdictional project consisting of financing and/or refinancing the (i) rehabilitation and improvements to an existing 13,000 square foot facility to be leased to a medical provider located at 1125 East Johnson in the City of Fond du Lac, Wisconsin, (ii) rehabilitation and improvements to an existing 10,000 square foot facility to be leased at N 6663 Rolling Meadows in the Town of Fond du Lac, Wisconsin, and (iii) payment of professional fees and costs of issuance (collectively, the "Project"); and

WHEREAS, the aggregate cost of the Project is presently estimated to be greater than \$20,000,000, and the aggregate amount proposed to be financed and/or refinanced with one or more series of taxable industrial development revenue bonds does not exceed \$20,000,000; and

WHEREAS, the proposed Project is a multi-jurisdictional project which is located in the City and the Town of Fond du Lac, Wisconsin ("Town of Fond du Lac"), and the Borrower has requested that the City and the Town of Fond du Lac each approve an initial resolution providing for the financing and/or refinancing of the Project in an aggregate amount not to exceed \$20,000,000; and

WHEREAS, on or about January 13, 2025, the Town of Fond du Lac proposes to consider an initial resolution providing for the financing and/or refinancing of the multi-jurisdictional Project, a portion of which is located in the City and the Town of Fond du Lac, in an aggregate amount not to exceed \$20,000,000; and

WHEREAS, the City shall be the issuer of said revenue bond; and

WHEREAS, the City is a municipality organized and existing under and pursuant to the laws of the State of Wisconsin, and is authorized to enter into revenue agreements with eligible participants with respect to the Project whereby eligible participants agree to cause said Project to be constructed and to pay the City an amount of funds sufficient to provide for the prompt payment when due of the principal and interest on said taxable industrial development revenue bonds; and

WHEREAS, the Borrower has requested that the City now approve an initial resolution providing for the financing and/or refinancing of the multi-jurisdictional Project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Fond du Lac, Wisconsin, as follows:

1. Based upon representations of the Borrower and the adoption of the initial resolution by the Town of Fond du Lac, it is the finding and determination of the City Council that the Project is a qualified "project" within the meaning of the Act and that the Borrower is an "eligible participant" within the meaning of the Act. If requested to do so by the Borrower, the City shall, subject to the conditions set forth in Section 2 below:

(a) Finance and/or refinance the Project in an aggregate amount not to exceed \$20,000,000; and

(b) Issue industrial development revenue bonds in one or more series of taxable bonds in an aggregate amount not to exceed \$20,000,000 (the "Bond(s)"), in order to finance and/or refinance costs of the Project, located in the City and the Town of Fond du Lac, pursuant to Section 66.1103(3)(f) of the Wisconsin Statutes.

2. The aforesaid plan of financing contemplates, and is conditioned upon, the following:

(a) The Bonds shall never constitute an indebtedness of either the City or the Town of Fond du Lac within the meaning of any state constitutional provision or statutory limitation;

(b) The Bonds shall not constitute or give rise to a pecuniary liability of either the City or the Town of Fond du Lac or a charge against their general credit or taxing powers;

(c) The Project shall be subject to property taxation in the same amount and to the same extent as though the Project were not financed and/or refinanced with industrial development revenue bonds;

(d) The portion of the Project located within the City is an eligible project under Section 66.1103(2)(k)(20) of the Act and falls under the City's 2040 Comprehensive Plan;

(e) The Borrower shall find a purchaser for all of the Bonds; and

(f) The City's out-of-pocket costs, including but not limited to issuance fees and legal fees in connection with the authorization, issuance and sale of the Bonds shall be paid by the Borrower.

3. The aforesaid plan of financing shall not be legally binding upon the City nor be finally implemented unless and until:

(a) The details and mechanics of the same are authorized and approved by a further resolution of the City Council which shall be solely within the discretion of the City Council;

(b) The City Clerk shall cause notice of adoption of this Initial Resolution, in the form attached hereto as <u>Exhibit A</u>, to be published once in a newspaper of general circulation in the City, and the electors of the City shall have been given the opportunity to petition for a referendum on the matter of the aforesaid Bond issue, all as required by law;

(c) Either no such petition shall be timely filed or such petition shall have been filed and said referendum shall have approved the Bond issue;

(d) The City and the Town of Fond du Lac shall have received an employment impact estimate issued under Section 238.11 of the Wisconsin Statutes;

(e) All documents required to consummate the financing have been duly authorized and delivered; and

(f) The City, the Town of Fond du Lac and the Borrower have resolved all land use and special use issues with respect to the affected property and the Project.

4. Pursuant to the Act, all requirements that the Project be subject to the contracting requirements contained in Section 66.1103 are waived, the Borrower having represented that it is able to negotiate satisfactory arrangements for completing the Project and that the City's interests are not prejudiced thereby.

5. The City Clerk is directed, following adoption of this Initial Resolution (i) to publish notice of such adoption not less than one time in the official newspaper of the City, such notice to be in substantially the form attached hereto as <u>Exhibit A</u> and (ii) to file a copy of this Initial Resolution, together with a statement indicating the date the Notice to Electors was published, with the Wisconsin Economic Development Corporation within twenty (20) days following the date of publication of such notice.

TAKE NOTICE that the City Council of the City of Fond du Lac, Wisconsin (the "City"), at a regular meeting held at City Hall, 160 South Macy Street, Fond du Lac, Wisconsin, on January 22, 2025, adopted an Initial Resolution pursuant to Section 66.1103 of the Wisconsin Statutes, as amended, expressing the intention to issue an aggregate amount not to exceed \$20,000,000 of industrial development revenue bonds of the City to be issued in one or more series of taxable bonds (the "Bonds") on behalf of 1125 East Johnson, LLC, a Wisconsin limited liability company, and N 6663 Rolling Meadows, LLC, a Wisconsin limited liability company, and/or a related entity, and/or an entity to be formed (individually and collectively, jointly and severally, the "Borrower"), to finance and/or refinance a multi-jurisdictional project consisting of the (i) rehabilitation and improvements to an existing 13,000 square foot facility to be leased to a medical provider located at 1125 East Johnson in the City of Fond du Lac, Wisconsin (the "1125 East Johnson Facility"), (ii) rehabilitation and improvements to an existing 10,000 square foot facility to be leased to a retailer located at N 6663 Rolling Meadows in the Town of Fond du Lac, Wisconsin (the "N 6663 Rolling Meadows Facility"), and (iii) payment of professional fees and costs of issuance (collectively, the "Project"). The Borrower has represented that 37 full-time jobs are expected to be created at the 1125 East Johnson Facility and 3 full-time jobs are expected to be created at the N 6663 Rolling Meadows Facility as a result of the Project.

Request for City of Fond du Lac, Wisconsin to Serve as Conduit Issuer

Not to Exceed Aggregate Amount of \$18,000,000 Taxable Industrial Development Revenue Bonds

to Benefit 1125 East Johnson, LLC and N 6663 Rolling Meadows, LLC Project

(multi-jurisdictional project located in City of Fond du Lac -and- Town of Fond du Lac)

This will summarize the request of 1125 East Johnson, LLC, a Wisconsin limited liability company, and N 6663 Rolling Meadows, LLC, a Wisconsin limited liability company, and/or a related entity, and/or an entity to be formed (collectively, the "Borrower"), asking that the City of Fond du Lac, Wisconsin (the "City of Fond du Lac") consider an Initial Resolution to benefit the Borrower through the conduit issuance of industrial development revenue bonds to be issued in one or more series of taxable bonds in an aggregate amount not to exceed \$18,000,000 (the "Bonds") to finance and/or refinance a multi-jurisdictional project located in both the City of Fond du Lac and the Town of Fond du Lac, Wisconsin (the "Town of Fond du Lac") consisting of the (i) rehabilitation and improvements to an existing 13,000 square foot facility to be leased to a medical provider located at 1125 East Johnson in the City of Fond du Lac, Wisconsin, (ii) rehabilitation and improvements to an existing 10,000 square foot facility to be leased to a retailer located at N 6663 Rolling Meadows in the Town of Fond du Lac, Wisconsin, and (iii) payment of professional fees and costs of issuance (collectively, the "Project"). In a conduit bond transaction, a state or local governmental entity issues bonds and loans the proceeds from the sale of the bonds to a private entity for an authorized project. In Wisconsin, counties, cities, villages and towns, as well as duly constituted redevelopment authorities and community development authorities, may issue conduit bonds.

As provided in the Project description above, the Project is a multi-jurisdictional Project, a portion of which is located in the City of Fond du Lac and the Town of Fond du Lac. Pursuant to Section 66.1103(3)(f) of the Wisconsin Statutes, a municipality may finance an industrial project which is located entirely outside the geographic limits of the municipality, but only if the revenue agreement for the project also relates to another project of the same eligible participant, part of which is located within the geographic limits of the municipality. Because the proposed Project is currently located in the City of Fond du Lac and the Town of Fond du Lac, the Borrower is requesting each municipality to consider an Initial Resolution authorizing the Bonds. The Town of Fond du Lac will consider an Initial Resolution on or about January 13, 2025. However, the Borrower is requesting that the City of Fond du Lac be the issuer of the conduit bonds.

These Bonds are municipal bonds; however, they are <u>not</u> general obligations of either the City of Fond du Lac or the Town of Fond du Lac. If the City of Fond du Lac agrees to issue bonds to benefit the proposed Project and the Town of Fond du Lac agrees:

1. Neither the City of Fond du Lac nor the Town of Fond du Lac will be liable for payment of the principal and interest on the Bonds.

2. Neither the City of Fond du Lac nor the Town of Fond du Lac will have ongoing responsibilities for monitoring or reporting with regard to the Bonds or the Project.

3. The Bonds <u>do not count</u> against either the City of Fond du Lac or the Town of Fond du Lac's borrowing capacity. Neither the City of Fond du Lac nor the Town of Fond du Lac will levy a tax for payment of the Bonds.

The City of Fond du Lac acts strictly as a conduit, which enables the Borrower to borrow at a lower rate of interest.

Because the Bonds are issued by a governmental entity, the holder of the Bonds may exclude the interest on the Bonds from gross income for federal tax purposes.

The cooperation of the City of Fond du Lac to act as the conduit issuer grants the Borrower a significant monetary benefit, at no cost to either the City of Fond du Lac or the Town of Fond du Lac, because the Borrower will enjoy a lower interest rate as a result of using a bond structure. A lending institution will directly purchase the Bonds. In the event that a payment is not made, the lending institution would look to the security and collateral pledged to them in the bond documents to be made whole. Bondholders will <u>not</u> look to the City of Fond du Lac or the Town of Fond du Lac for payment. The City of Fond du Lac, as the conduit issuer, will assign all of its rights, liability and responsibilities under the Bonds to the lender as the bondholder. The Borrower will be fully responsible for repaying the loan and must make the arrangements with the lender for the payment on the Bonds. If the Borrower is not able to meet its payment obligations, the lender will realize on its collateral and enforce its rights against the Borrower. Neither City of Fond du Lac nor the Town of Fond du Lac is liable for payment.

The foregoing is just a brief discussion of conduit taxable industrial development revenue bond financing. The Borrower respectfully asks that the City Council consider the Initial Resolution at its January 22, 2025 meeting. The Initial Resolution is not a binding obligation of the City of Fond du Lac to issue the Bonds, nor is it a binding obligation of the Borrower to utilize bond financing, unless and until further action is taken; however, adoption of the Initial Resolution will preserve and maintain eligibility for the Project to utilize bond financing at a later date.

City of Fond du Lac Policy for Public Deposits and Investments

I. Public Deposits

A. **Public Depositories.** The City Council shall by resolution designate one or more public depositories, organized and doing business under the laws of this state or federal law, and located in Wisconsin, in which the City Treasurer (Director of Administration) shall deposit all public monies received by him/her.

B. Limitations. The resolution designating one or more public depositories shall specify whether the monies shall be maintained in time deposits, demand deposits or savings deposits, and whether a surety bond or other security shall be required to be furnished under Section 34.07 of the Wisconsin Statutes, by the public depository to secure the repayment of such deposits.

C. Deposits. The City Treasurer shall deposit public monies in the name of the City of Fond du Lac in such public depositories designated by the City Council and subject to the limitations hereinabove set forth.

D. Withdrawals. Withdrawals or disbursements by the City Treasurer of monies deposited in a public depository shall be made as provided by Section 66.0607 (1) to (7) of the Wisconsin Statutes, or as subsequently amended. The City Treasurer is authorized, at his/her discretion, to process periodic payments through the use of money transfer techniques as set forth in Section 66.0607(3m) of the Wisconsin Statutes, or as subsequently amended.

II. Investments

A. Policy. It is the policy of the City of Fond du Lac to invest public funds in a manner which will provide the highest investment return with the maximum security while meeting the daily cash flow needs of the City and conforming to all state statutes governing the investment of public funds.

B. Scope. This investment policy applies to all financial assets of the City of Fond du Lac. These assets are accounted for in the City's **Comprehensive Annual Financial Report** and include the City's General Fund, Special Revenue Funds, Debt Service Funds, Capital Project Funds, Enterprise Funds (Wastewater Utility and Water Utility), Internal Services Funds, Trust and Agency Funds, and any new funds which may be established by the City Council.

C. Prudence. Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence

exercise in the managing of their own affairs, not for speculation, but for investment, considering the probable safety of their capital as well as the probable income to be derived.

The standard of prudence to be used by investment officials shall be the "prudent person" standard and shall be applied in the context of managing an overall portfolio. Investment officers acting in accordance with written procedures and the investment policy and exercising due diligence shall be relieved of personal responsibility for an individual security's credit risk or market price changes, provided deviations from expectations are reported in a timely fashion and appropriate action is taken to control adverse developments.

D. Objectives. The primary objectives of the City's investment activities, in priority order, shall be:

D.1. Safety. Safety of principal is the foremost objective of the investment program. Investments of the City shall be undertaken in a manner that seeks to ensure the preservation of capital in the overall portfolio.

D.2. Liquidity. The City's investment portfolio will remain sufficiently liquid to enable the City to meet all operating cash requirements, which may be reasonably anticipated.

D.3. Return on Investments. The City's investment portfolio shall be designed with the objective of attaining a rate of return throughout budgetary and economic cycles, commensurate with the City's investment risk constraints and the cash flow characteristics of the portfolio.

E. Delegation of Investment Authority. Management responsibility for the City's investment program is hereby delegated to the Director of Administration, who shall have control of and discretion in the investment of all City funds that are not immediately needed and are available for investment. The Director of Administration shall establish written procedures for the operation of the investment program consistent with this investment policy. Such procedures shall include explicit delegation of authority to other persons responsible for investment transactions. No person may engage in an investment transaction except as provided under the terms of this policy and the procedures established by the Director of Administration. The Director of Administration shall establish a system of controls to regulate the activities of subordinate officials.

F. Ethics and Conflicts of Interest. City employees involved in the investment process shall refrain from personal business activity that could conflict with proper execution of the investment program, or which could impair their ability to make impartial investment decisions.

G. Authorized Financial Dealers and Institutions. The Director of Administration will maintain a list of financial institutions authorized to provide investment services. In addition, a list will also be maintained of approved security broker/dealers selected by

credit worthiness who are authorized to provide investment services in the State of Wisconsin.

To be eligible as a broker/dealer, the firm and the designated representative must be registered in the State of Wisconsin. In addition, the firm must meet at least one of the following criteria:

- 1. Be recognized as a Primary Dealer by the Federal Reserve Bank of New York or have a Primary Dealer within its holding company structure,
- 2. Report voluntarily to the Federal Reserve Bank of New York,
- 3. Qualify under Securities and Exchange Commission (SEC) Rule 15c3-I (Uniform Net Capital Rule).

The City may engage the services of an investment advisor to assist in the management of the portfolio. Such investment advisor may utilize its own list of approved broker/dealers; however, the list shall comply with the above criteria and shall be provided to the City on an annual basis or upon request.

H. Authorized and Suitable Investments. City funds may be invested in the following types of securities, in accordance with Section 66.0603 of the Wisconsin Statutes:

H.1. Certificates of Deposit. City funds may be invested in certificates of deposit maturing within three years or less issued by any credit union, bank, savings bank, trust company or savings and loan association authorized to transact business in the State of Wisconsin provided the financial institution has been designated as a public depository by a resolution of the City Council.

H.2. Government Bonds & Securities. City funds may be invested in United States Government bonds or securities or bonds or securities issued or guaranteed as to principal and interest by the federal government, or by any commission, board or other instrumentality of the federal government, or bonds or securities of any county, city, village, town, school district, technical college district or drainage district located in Wisconsin. Maturities for government bonds and securities shall not exceed seven years from the date of trade settlement.

H.3. Repurchase Agreements. The City may engage in financial transactions in which a financial institution, designated as a public depository by a resolution of the City Council, agrees to repay funds advanced to it by the City, plus interest, if the agreement is secured by bonds or securities which are issued or guaranteed as to principal and interest by the federal government. A master repurchase agreement must be signed with the financial institution.

H.4. Savings Deposits. City funds may be invested in savings deposits in any financial institution designated as a public depository by resolution of the City Council.

H.5. Wisconsin Local Government Investment Pool. City funds may be invested in the Wisconsin Local Government Investment Pool.

H.6. Wisconsin Investment Trust. City funds may be invested in the League of Wisconsin Municipalities Wisconsin Investment Trust.

H.7. Commercial Securities. City funds may be invested in any security, which matures within not more than five years from the date of trade settlement and is rated at least AA- by Standard & Poor's Corporation, Aa3 by Moody's Investors Service or AA- by Fitch Ratings at the time of purchase. Further, at the time of purchase, commercial securities shall not be rated less than A- by Standard & Poor's Corporation, A3 by Moody's Investors Service or A- by Fitch Ratings. Combined investments in commercial securities shall not exceed 30% of the portfolio with no more than 5% held in any one issuer, at the time of purchase. Subordinated debt is not authorized. Securities that have been downgraded below the minimum ratings may be sold or held at the City's discretion.

H.8. Money Market Mutual Funds. City funds may be invested in money market mutual funds which are registered under the Investment Company Act of 1940; are no-load; limit the assets of the fund to obligations of the federal government or its agencies or instrumentalities and repurchase agreements collateralized by the federal government or its agencies or instrumentalities.

I. Collateralization. Collateralization will be required on two types of investments: repurchase agreements and certificates of deposit. In order to anticipate market changes and to provide a level of security, the collateralization level shall be (102%) of market value of principal and accrued interest. The City limits collateral to U.S. Government or U.S. Government Agency securities. Collateral will always be held by an independent third party with whom the City has a current custodial agreement. A clearly marked evidence of ownership (safekeeping receipt) must be supplied to the City and retained. The right of collateral substitution is granted.

J. Safekeeping and Custody. All security transactions, including collateral for certificates of deposit and repurchase agreements, entered into by the City shall be conducted on a **delivery-versus-payment (DVP)** basis. Securities will be held by a third party custodian designated by the Director of Administration and evidenced by safekeeping receipts.

K. Internal Control. The City shall establish an annual process of independent review by an external auditor. This review will provide internal control by assuring compliance with investment policies.

L. Performance Standards. The investment portfolio shall be designed with the objective of obtaining a rate of return throughout budgetary and economic cycles, commensurate with the investment risk constraints and the cash flow needs of the City. The City's investment strategy is passive. Given this strategy, the basis used by the Director of Administration to determine whether market yields are being achieved shall be the 90-day U.S. Treasury Bill, the average Federal Funds rate and the 1-3 Year Treasury Index.

M. Reporting Requirements. The Director of Administration is charged with the responsibility for including a market report on investment balances and returns in the City's Comprehensive Annual Financial Report.

N. Definitions and Conflict. This policy is enacted in accordance with the provisions of Chapter 34 and Section 66.0603 of the Wisconsin Statutes. Words and phrases shall, insofar as applicable, have the meaning set forth in Sections 34.01 and 66.0603 of the Wisconsin Statutes. In case of conflict, state laws shall prevail.

O. Adoption and Duration. The City's investment policy shall be adopted by resolution of the City Council, and shall remain in force until repealed or superseded by further resolution of the City Council.

Resolution 7390, adopted in 2002, authorizes the policy for holding public funds in investment accounts. Periodically our investment advisor will review the policy to ensure that it complies with Internal Revenue Service (IRS) and Securities and Exchange (SEC) regulations. The changes noted in the redlined version of the policy attached to this memo are to ensure compliance with those regulations.

The City takes a very conservative approach by investing funds primarily in the Local Government Investment Pool managed by the State of Wisconsin, and in US Treasury and US Agency bonds and notes. Section H of the resolution outlines and authorizes the areas that funds may be invested. The addition of investing funds in Money Market Mutual Funds will give some flexibility to invest smaller amounts of funds, in order to accumulate them to purchase larger bonds and notes when available.

These assets are accounted for in the City's Comprehensive Annual Financial Report and include the City's General Fund, Special Revenue Funds, Debt Service Funds, Capital Project Funds, Enterprise Funds (Wastewater Utility and Water Utility), Internal Services Funds, Trust and Agency Funds, and any new funds which may be established by the City Council.

C. Prudence. Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence exercise in the managing of their own affairs, not for speculation, but for investment,

considering the probable safety of their capital as well as the probable income to be derived.

The standard of prudence to be used by investment officials shall be the "prudent person" standard and shall be applied in the context of managing an overall portfolio. Investment officers acting in accordance with written procedures and the investment policy and exercising due diligence shall be relieved of personal responsibility for an individual security's credit risk or market price changes, provided deviations from expectations are reported in a timely fashion and appropriate action is taken to control adverse developments.

D. Objectives. The primary objectives of the City's investment activities, in priority order, shall be:

D.1. Safety. Safety of principal is the foremost objective of the investment program. Investments of the City shall be undertaken in a manner that seeks to ensure the preservation of capital in the overall portfolio.

D.2. Liquidity. The City's investment portfolio will remain sufficiently liquid to enable the City to meet all operating cash requirements, which may be reasonably anticipated.

D.3. Return on Investments. The City's investment portfolio shall be designed with the objective of attaining a rate of return throughout budgetary and economic cycles, commensurate with the City's investment risk constraints and the cash flow characteristics of the portfolio.

E. Delegation of Investment Authority. Management responsibility for the City's investment program is hereby delegated to the Director of Administration, who shall have control of and discretion in the investment of all City funds that are not immediately needed and are available for investment. The Director of Administration shall establish written procedures for the operation of the investment program consistent with this investment policy. Such procedures shall include explicit delegation of authority to other persons responsible for investment transactions. No person may engage in an investment transaction except as provided under the terms of this policy and the procedures established by the Director of Administration. The Director of Administration shall be responsible for all investment transactions undertaken and shall establish a system of controls to regulate the activities of subordinate officials.

F. Ethics and Conflicts of Interest. City employees involved in the investment process shall refrain from personal business activity that could conflict with proper execution of the investment program, or which could impair their ability to make impartial investment decisions.

G. Authorized Financial Dealers and Institutions. The Director of Administration will maintain a list of financial institutions authorized to provide investment services. In addition, a list will also be maintained of approved security broker/dealers selected by credit worthiness who are authorized to provide investment services in the State of

Wisconsin. These may include "primary dealers" or regional dealers that qualify under Securities & Exchange Commission Rule 15C3-1 (uniform net capital rule).

All financial institutions and broker/dealers who desire to become qualified bidders for investment transactions must supply the Director of Administration with the following:

- Audited Financial Statements
- Proof of National Association of Security Dealers certification
- Trading resolution
- Proof of State registration
- Certification of having read the City's investment policy.

An annual review of the financial condition and registrations of qualified bidders will be conducted by the Director of Administration.

A current audited financial statement is required to be on file for each financial institution and broker/dealer in which the City invests.

To be eligible as a broker/dealer, the firm and the designated representative must be registered in the State of Wisconsin. In addition, the firm must meet at least one of the following criteria:

- 1. Be recognized as a Primary Dealer by the Federal Reserve Bank of New York or have a Primary Dealer within its holding company structure,
- 2. Report voluntarily to the Federal Reserve Bank of New York,
- 3. Qualify under Securities and Exchange Commission (SEC) Rule 15c3-I (Uniform Net Capital Rule).

The City may engage the services of an investment advisor to assist in the management of the portfolio. Such investment advisor may utilize its own list of approved broker/dealers; however, the list shall comply with the above criteria and shall be provided to the City on an annual basis or upon request.

H. Authorized and Suitable Investments. City funds may be invested in the following types of securities, in accordance with Section 66.0603 of the Wisconsin Statutes:

H.1. Certificates of Deposit. City funds may be invested in certificates of deposit maturing within three years or less issued by any credit union, bank, savings bank, trust company or savings and loan association authorized to transact business in the State of Wisconsin provided the financial institution has been designated as a public depository by a resolution of the City Council.

H.2. Government Bonds & Securities. City funds may be invested in United States Government bonds or securities or bonds or securities issued or guaranteed as to principal and interest by the federal government, or by any commission, board or other instrumentality of the federal government, or bonds

or securities of any county, city, village, town, school district, technical college district or drainage district located in Wisconsin.<u>Maturities for government bonds</u> and securities shall not exceed seven years from the date of trade settlement.

H.3. Repurchase Agreements. The City may engage in financial transactions in which a financial institution, designated as a public depository by a resolution of the City Council, agrees to repay funds advanced to it by the City, plus interest, if the agreement is secured by bonds or securities which are issued or guaranteed as to principal and interest by the federal government. A master repurchase agreement must be signed with the financial institution.

H.4. Savings Deposits. City funds may be invested in savings deposits in any financial institution designated as a public depository by resolution of the City Council.

H.5. Wisconsin Local Government Investment Pool. City funds may be invested in the Wisconsin Local Government Investment Pool.

H.6. Wisconsin Investment Trust. City funds may be invested in the League of Wisconsin Municipalities Wisconsin Investment Trust.

H.7. Commercial Securities. City funds may be invested in any security which matures within not more than seven five years fromef the date it is acquiredof trade settlement, if that security and has a rating which is the highest or second highest rating category assigned by is rated at least AA- by Standard & Poor's Corporation, Aa3 by Moody's Investors Service or AA- by Fitch Ratings at the time of purchase. Further, at the time of purchase, commercial securities shall not be rated less than A- by Standard & Poor's Corporation, A3 by Moody's Investors Service or AA- by Fitch Ratings at the time of purchase. Further, at the time of purchase, commercial securities shall not be rated less than A- by Standard & Poor's Corporation, A3 by Moody's Investors Service or A- by Fitch Ratings. Combined-other similar nationally recognized rating agency. investments in commercial securities shall not exceed 30% of the portfolio with no more than 5% held in any one issuer, at the time of purchase. Subordinated debt is not authorized. Securities that have been downgraded below the minimum ratings may be sold or held at the City's discretion.

H.8. Money Market Mutual Funds. City funds may be invested in money market mutual funds which are registered under the Investment Company Act of 1940; are no-load; limit the assets of the fund to obligations of the federal government or its agencies or instrumentalities and repurchase agreements collateralized by the federal government or its agencies or instrumentalities.

I. Collateralization. Collateralization will be required on two types of investments: repurchase agreements and certificates of deposit. In order to anticipate market changes and to provide a level of security, the collateralization level shall be (102%) of market value of principal and accrued interest. The City limits collateral to U.S. Government or U.S. Government Agency securities. Collateral will always be held by an independent third party with whom the City has a current custodial agreement. A clearly marked evidence of ownership (safekeeping receipt) must be supplied to the City and retained. The right of collateral substitution is granted.

J. Safekeeping and Custody. All security transactions, including collateral for certificates of deposit and repurchase agreements, entered into by the City shall be conducted on a **delivery-versus-payment (DVP)** basis. Securities will be held by a third party custodian designated by the Director of Administration and evidenced by safekeeping receipts.

K. Internal Control. The City shall establish an annual process of independent review by an external auditor. This review will provide internal control by assuring compliance with investment policies.

L. Performance Standards. The investment portfolio shall be designed with the objective of obtaining a rate of return throughout budgetary and economic cycles, commensurate with the investment risk constraints and the cash flow needs of the City. The City's investment strategy is passive. Given this strategy, the basis used by the Director of Administration to determine whether market yields are being achieved shall be the 90-day U.S. Treasury Bill, the -and-average Federal Funds rate and the 1-3 Year Treasury Index.

M. Reporting Requirements. The Director of Administration is charged with the responsibility for including a market report on investment balances and returns in the City's Comprehensive Annual Financial Report.

N. Definitions and Conflict. This policy is enacted in accordance with the provisions of Chapter 34 and Section 66.0603 of the Wisconsin Statutes. Words and phrases shall, insofar as applicable, have the meaning set forth in Sections 34.01 and 66.0603 of the Wisconsin Statutes. In case of conflict, state laws shall prevail.

O. Adoption and Duration. The City's investment policy shall be adopted by resolution of the City Council, and shall remain in force until repealed or superseded by further resolution of the City Council.

BE IT FURTHER RESOLVED that any prior resolution inconsistent with this resolution is hereby repealed and rescinded to the extent of such inconsistency.

AN ORDINANCE AMENDING THE CITY OF FOND DU LAC 2040 COMPREHENSIVE PLAN

WHEREAS, the Plan Commission of the City of Fond du Lac adopted the "City of Fond du Lac 2040 Comprehensive Plan" (Comprehensive Plan) via Plan Commission Resolution No. 2021-01 and the City Council adopted the Comprehensive Plan via Ordinance No. 3731, and

WHEREAS, the Comprehensive Plan adopts the "Future Land Use Map", incorporating the recommended future land use goals and policies into Chapter 9: Land Use; and

WHEREAS, the "Future Land Use Map" guides future planning and location of development that will meet the said goals and policies of Chapter 9: Land Use and Comprehensive Plan; and

WHEREAS, the environment in which the Comprehensive Plan is implemented is dynamic, it is expected that amendments to the Comprehensive Plan may be needed to address changing conditions; and

WHEREAS, the Future Land Use Map may be amended following the criteria set forth in Chapter 9: Land Use; and

WHEREAS, the amended Future Land Use Map will enable the expansion of an institutional healthcare facility currently limited within its existing boundaries and will reflect the uses of these parcels for such use; and

WHEREAS, a copy of the Future Land Use amendment is attached hereto as Exhibit A as Comp Plan Amendment No. 5, incorporated by reference, and

WHEREAS, the Plan Commission recommended approval of the Comprehensive Plan amendment at its meeting held on January 13, 2025.

Now therefore, the City Council of the City of Fond du Lac do ordain as follows:

PART I. The "City of Fond du Lac 2040 Comprehensive Plan" and Future Land Use Map are hereby amended to the depicted in Exhibit A of this resolution.

PART II. All ordinances and parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. The provisions of this ordinance shall be in full force and effect from and after its passage and publication.



The Comprehensive Plan identifies where growth should occur and makes recommendations of future development. Reflective of the dynamics of development and growth, the Comprehensive Plan carries an expectation that amendments would be needed to address changing conditions of land use and development.

The four parcels identified above are located on the west side of Eastgate Place, accessible from East Division Street. The Comprehensive Plan identifies all four parcels as residential land use.

SSM Health is requesting a rezoning of the parcels to O Office Conversion District. The properties have been acquired and the structures are in the process of being razed.

In considering appropriate zoning for a property, continuity between zoning and land use is required. In other words, the *zoning* of a property must reflect the *use* of the property. The proposed office zoning of the subject properties conflicts with the existing land use designations for residential uses; therefore, a change to the Comprehensive Plan is necessary in order for the zoning to change.

The suggested institutional land use designation would represent the future land use. The proposed land use designation reflects the institutional (healthcare) expansion anticipated for the subject properties. The proposed expansion of the facility is limited on the current site due to the creek (and subsequently Division Street bridge) to the south and west. This limits not only the building expansion, but circulation as well.

The Comprehensive Plan Amendment and rezoning proposal will be considered as separate items on the January 13th Plan Commission agenda.


Recommendation





The subject properties are located along the west side of Eastgate Place. Eastgate Place is a short street that is accessed from East Division Street. The properties are zoned R-1 (Single Family Residential District); a change of zoning to O (Office Conversion District) is proposed. The four lots total 0.927 acres and had single family homes that are razed or in the process of being razed. The request to rezone to O District is consistent with the adjoining land use and reflect the future desired use of the property. SSM Health is looking to expand the Cancer Center. The location of the creek to the south limits expansion in that direction. It also hinders altering or widening access at the Division Street driveway. The proposed expansion plans do include an access drive onto Eastgate Place.

The proposed rezoning would extend the area of existing O District to the subject sites. The proposed rezoning also reflects the intended use of the property (cancer center/healthcare services). Approval of the proposed rezoning would not create a negative effect or harm to any adjacent or nearby property.

In order for the project to proceed, the applicant would be required to obtain a Special Use Permit since it is located within 200 feet of properties zoned for residential use or residential purposes. The Special Use Permit process will enable the Plan Commission to establish conditions to address any concerns. Such conditions can address landscape buffers, lighting and other elements.



Rezone Narrative

Project: SSM Health – Cancer Center Expansion

SSM Health is requesting rezone review and approval for (4) parcels located on Eastgate Place to allow for a proposed building and parking expansion to the existing cancer center located at 480 E. Division Street in the City of Fond du Lac. The rezoning is proposed from R-1 to O-Office Conversion District for 14 Eastgate Place (FDL-15-17-11-43-527-00), 20 Eastgate Place (FDL-15-17-11-43-526-00), 28 Eastgate Place (FDL-15-17-11-43-525-00) and 36 Eastgate Place (FDL-15-17-11-43-525-00).


The proposed site revisions are represented in the submitted concept site plan layout. The rezoning is the first step in the entitlement process to allow for the expansion. After rezone approval, the rezoned lots will be added to the main parcel via certified survey map and a special use permit will be applied for to allow for the medical clinic use.

There is an increasing demand for cancer treatment in Fond du Lac, in an effort to support the demand, SSM would like to expand the existing Cancer Center building. The existing facility currently has 12 treatment bays and the planned expansion hopes to increase that to 30 treatment bays. The current hours of operation for the Cancer Center is Monday-Friday from 7:30 AM to 4:30 PM this will be maintained with the expansion. With the increased patient volumes the parking lot will also be expanded to accommodate the increased parking demand. Cancer treatments typically take 3-4 hours so the increased volume of patients is expected to have minimal impact on the neighboring traffic as patients are less transient.

Due to the site constraints the addition needs to extend out east of the existing building which eliminates the existing street access on the east of the building. We have evaluated changing the existing west entrance point to allow for 2-way traffic to and from the site, but this effort would eliminate a significant portion of existing parking stalls. So we would be looking to add a new drive aisle from Eastgate Place so that we can preserve parking capacity so patients & providers will have adequate on site parking.

SSM recognizes that the environment where cancer treatment is delivered is an important factor in outcomes, patients respond better to treatment when they have better access to nature while maintaining privacy. To accomplish this on the site we will be utilizing landscape screening around the perimeter of the addition to establish a park like quality environment for both the occupants in the building, but also for the neighboring properties. The parking lot lighting will utilize directional lighting to insure the light spill to the neighboring properties will be kept to a minimum. WE will also be providing landscape berms around the expanded parking to further afford patient privacy and maintaining a park like quality throughout the entire site experience.

The goal for the project team is to begin construction in the summer of 2025.



In July of 2024, you approved this ordinance regarding Class C liquor licenses. The Editor for General Code noticed in Section 3. that I attempted to amend Ch. 400-14, which is being held in reserve. It doesn't currently exist, so it can't be amended. To rectify my error, I've revised the ordinance to add the wording I tried to add to Section 400-14 to Section 400-6 which is a more appropriate place to add the wording.

<u>Requested Action</u> We'd ask you to approve Amended Ordinance 3791.

ORDINANCE NO. 3791 AMEMDED

AN ORDINANCE AMENDING CHAPTER 400, INTOXICATING LIQUORS AND FERMENTED MALT BEVERAGES, OF THE CODE OF THE CITY OF FOND DU LAC TO

The City Council of the City of Fond du Lac do ordain as follows:

Section 1. That Section 400-1, <u>Adoption of Statutory Provisions</u>, is hereby amended as follows:

Add Thereto:

1. Sale of Alcohol Beverages to Underage Persons.

(a) No person may procure for, sell, dispense or give away any alcohol beverages to any underage person not accompanied by their parent, guardian or spouse who has attained the legal drinking age.

(b) No licensee or permittee may sell, vend, deal or traffic in alcohol beverages to or with any underage person not accompanied by their parent, guardian or spouse who has attained the legal drinking age.
(c) No adult may knowingly permit or fail to take action to prevent the illegal consumption of alcohol beverages by an underage person on premises owned by the adult or under the adult's control. This subdivision does not apply to alcohol beverages used exclusively as part of a religious service.

(d) No adult may intentionally encourage or contribute to a violation of sub. (4) (a) or (b).

2. **Defenses.** In determining whether a licensee or permittee has violated Sub. (3)(a), all relevant circumstances surrounding the presence of the underage person or the procuring, selling, dispensing or giving away of alcohol beverages may be considered, including any circumstance under subdiv. (a) to (d). In addition, proof of all of the following facts by a seller of alcohol beverages to an underage person is a defense to any prosecution for a violation of this section.

(a) That the purchaser falsely represented that they had attained the legal drinking age.

(b) That the appearance of the purchaser was such that an ordinary and prudent person would believe that the purchaser had attained the legal drinking age.

(c) That the sale was made in good faith and in reliance on the representation and appearance of the purchaser in the belief that the purchaser had attained the legal drinking age.

(d) That the underage person supported the representation under subdiv. (a) with documentation that they had attained the legal drinking age.

3. Book Kept by Licensees and Permittees.

(a) Every retail alcohol beverage licensee or permittee may keep a book for the purposes of Subsection (4). The licensee or permittee or their employee may require any of the following persons to sign the book:

1. A person who has shown documentary proof that they have attained the legal drinking age if the person's age is in question.

- 1. 2. A person who alleges that they are the underage person's parent, guardian or spouse and that they have attained the legal drinking age, if the licensee or permittee or their employee suspects that they are not the underage person's parent, guardian or spouse or that they have not attained the legal drinking age.
- 2. (b) The book may show the date of the purchase of the alcohol beverages, the identification used in making the purchase or the identification used to establish that a person is an underage person's parent, guardian or spouse and has attained the legal drinking age, the address of the purchaser and the purchaser's signature.

4. Proof of Age.

(a) <u>Definition.</u> In this section, "official identification card" means a valid operator's license issued under Wis. Stat. ch. 343, that contains the photograph of the holder, an identification card issued under Wis. Stat. § 343.50 or an identification card issued under Wis. Stat. 1987 § 125.08.
(b) <u>Use</u>. No card other than the identification card authorized under this section may be recognized as an official identification card in this state. In place of an official identification card, documentary proof under Wis. Stat. § 125.07(7) may be substituted.

(c) No person may make, alter or duplicate an official identification card, provide an official identification card to an underage person or knowingly provide other documentation to an underage person purporting to show that the underage person has attained the legal drinking age. No person may possess an official identification card or other documentation used for proof of age with the intent of providing it to an underage person.

Section 2. That Section 400-6, <u>Issuance of Licenses</u>, is hereby amended as follows:

Add Thereto:

H. Class "B" License Requirements

- 1. The Class "B" licensed establishment must have a completely separate premises description from all other licensed establishments and comply with all relevant provisions of Wis. Stat. Ch. 125 and the Code of the City of Fond du Lac. The following requirements must be met before the license can be issued.
- 2. Separate premises must include the following:
 - a. The two businesses cannot permit cross access besides an emergency exit.
 - b. The two businesses must be completely walled off from one another.
 - c. Customers cannot easily go back and forth between the two businesses while consuming alcohol.
 - d. There ae separate outside entrances to each of the two businesses.
 - e. There are separate counters at each location that can specifically monitor the requirements of each separate license.
- 3. The applicant must submit a site plan to the City of Fond du Lac Inspections Department showing said separate premises descriptions.
- 4. The property must pass all inspections with the City of Fond du Lac Inspections and Fire Departments and Fond du Lac County Health Department (when applicable), and obtain an occupancy permit.

I. "Class C" License Requirements.

- "Class C" license authorizes the retail sale of wine by the glass or in an opened original container for consumption on the premises where sold. For establishments with two land uses, they are only available to the types of uses shown in Schedule I, see attached. For a Wine Bar, where there is only the land use of a drinking establishment or restaurant that just serves wine, the closing hours may mirror those of a "Class B" or Class "B" license.
 - i. A "Class C" license shall particularly describe the premises for which it is issued.
 - ii. The fee for a "Class C" license shall be as shown in the fee schedule.

iii. Operator's or Manager's License. An Operator's or Manager's license shall permit its holder to serve or sell alcohol beverages and is required for a Class C license.

2. Class C Hours.

(a) <u>Premises Hours</u>. No premises which is more than one land use for which a Class C alcohol beverage license shall have been issued shall be permitted to remain open for the sale or dispensing of alcohol beverages between the hours of 9:00 p.m. and 8:00 a.m. but shall be permitted to stay open for the conduct of their regular business.

(b) <u>Regulation of Closed Retail Space.</u> Only the permitted, licensee, employees, salespersons, employees of wholesalers licensed under Wis. Stat. § 125.28(1) or 125.54(1), or service personnel may be present on Class C premises during hours when the premises are not open for business if those persons are performing job-related activities. All other employees and patrons shall vacate the premises at 9:00 p.m.

J. Additional General Requirements.

1. Intoxicated Persons.

(a) <u>Restrictions</u>.

 No person may procure for, sell, dispense, or give away alcohol beverages to a person who is intoxicated.
 No licensee or permittee may sell, vend, deal or traffic in alcohol beverages to or with a person who is intoxicated.
 No licensee or permittee may permit an intoxicated person to be on a licensed premises.

2. Licensee/Operator under the Influence.

It shall be unlawful for the licensee or any employee of a licensed establishment to be under the influence of an intoxicant, or a controlled substance or a combination of an intoxicant and a controlled substance, while performing services on the licensed premises

3. Identification of Patrons 21 Years of Age and Older. Any licensed establishment that meets the exceptions contained in Section 125, Wisconsin Statutes and Chapter 400-1 of the Fond du Lac Code for allowing underage patrons on the licensed

premise, must have a means of visually and conspicuously identifying patrons who are twenty-one (21) years of age and older. It shall be the sole responsibility of the license holder to determine whether any of the exceptions contained in Wis. Stat. § 125, and Section 400-1, Fond du Lac Code, apply to their establishment.

- 4. Control of Premises. At no time may licensee relinquish control of the licensed premises or the service of alcohol to any other person or entity. The licensee must remain in control of the premises and must continue to be in control of the alcohol and service thereof through the licensee's own employees, including but not limited to checking identification of patrons, collecting money or tickets from patrons for drinks, or for charges for entry to the establishment or any area within the establishment, during all events, including private parties. The licensee and its employees will be held responsible for all conduct taking place on its premises at all times including conduct taking place during private parties. Notwithstanding the limitations of this subdivision, a licensee may contract with an agency that is licensed by the State of Wisconsin as a supplier of uniformed private security personnel to engage in private security activities.
- 5. Face-to-face Retail Sales. Except as provided in Wis. Stat. § 125.26(2m), 125.26(2s), 125.51(3)(bm) and 125.51(bs), and except with respect to caterers, a retail alcohol license issued under this chapter authorizes only face-to-face sales to consumers at the premises described in the retail license.
- 6. Wholesaler Source. No retail licensee shall purchase alcohol beverages from any source other than a licensed wholesaler, except as permitted by state law.
- 7. **Conditions on License**. A licensee shall comply with all conditions placed upon its license by action of the City Council.
- 8. Exceeding Lawful Occupancy Capacity.

(a) No licensee or person shall permit or allow occupancy of the licensed premise in excess of the lawfully established occupancy capacity. Occupancy capacity includes all staff and persons on the premise.

(b) Exceeding lawful occupancy capacity by more than thirty percent (30%) shall result in an enhanced penalty.

9. **Penalty**. In addition to the suspension or revocation of any license issued under this chapter, and except where otherwise specifically provided, any person found to be in violation of any provisions of

this chapter or any order, rule or regulation made hereunder shall be subject to a penalty as provided in § 1-4 of this Code.

Section 4. Any person violating the provisions of this Ordinance shall be subject to the penalty provided in Section 1-4 of the Code.

<u>Section 5</u>. The appropriate City officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.

<u>Section 6</u>. All other ordinances and resolutions inconsistent with the provisions of this Ordinance are hereby repealed.

Section 7. This Ordinance shall take effect and be in force upon its passage and publication as provided by law.

ORDINANCE NO. 3791

AN ORDINANCE AMENDING CHAPTER 400, INTOXICATING LIQUORS AND FERMENTED MALT BEVERAGES, OF THE CODE OF THE CITY OF FOND DU LAC TO FURTHER DEFINE NO SALES OF ALCOHOL TO UNDERAGE PERSONS, DEFINE CONDITIONS FOR CLASS "B" LICENSES AND DEFINE THE REQUIREMENTS FOR A "CLASS C" LICENSE

The City Council of the City of Fond du Lac do ordain as follows:

<u>Section 1.</u> That Section 400-1, <u>Adoption of Statutory Provisions</u>, is hereby amended as follows:

Add Thereto:

1. Sale of Alcohol Beverages to Underage Persons.

(a) No person may procure for, sell, dispense or give away any alcohol beverages to any underage person not accompanied by their parent, guardian or spouse who has attained the legal drinking age.
(b) No licensee or permittee may sell, vend, deal or traffic in alcohol beverages to or with any underage person not accompanied by their parent, guardian or spouse who has attained the legal drinking age.
(c) No adult may knowingly permit or fail to take action to prevent the illegal consumption of alcohol beverages by an underage person on premises owned by the adult or under the adult's control. This subdivision does not apply to alcohol beverages used exclusively as part of a religious service.

(d) No adult may intentionally encourage or contribute to a violation of sub. (4) (a) or (b).

2. Defenses. In determining whether a licensee or permittee has violated Sub. (3)(a), all relevant circumstances surrounding the presence of the underage person or the procuring, selling, dispensing or giving away of alcohol beverages may be considered, including any circumstance under subdiv. (a) to (d). In addition, proof of all of the following facts by a seller of alcohol beverages to an underage person is a defense to any prosecution for a violation of this section.

(a) That the purchaser falsely represented that they had attained the legal drinking age.

. .*

(b) That the appearance of the purchaser was such that an ordinary and prudent person would believe that the purchaser had attained the legal drinking age.

(c) That the sale was made in good faith and in reliance on the representation and appearance of the purchaser in the belief that the purchaser had attained the legal drinking age.

(d) That the underage person supported the representation under subdiv. (a) with documentation that they had attained the legal drinking age.

3. Book Kept by Licensees and Permittees.

(a) Every retail alcohol beverage licensee or permittee may keep a book for the purposes of Subsection (4). The licensee or permittee or their employee may require any of the following persons to sign the book:

1. A person who has shown documentary proof that they have attained the legal drinking age if the person's age is in question.

- a. 2. A person who alleges that they are the underage person's parent, guardian or spouse and that they have attained the legal drinking age, if the licensee or permittee or their employee suspects that they are not the underage person's parent, guardian or spouse or that they have not attained the legal drinking age.
- b. (b) The book may show the date of the purchase of the alcohol beverages, the identification used in making the purchase or the identification used to establish that a person is an underage person's parent, guardian or spouse and has attained the legal drinking age, the address of the purchaser and the purchaser's signature.

4. Proof of Age.

(a) <u>Definition.</u> In this section, "official identification card" means a valid operator's license issued under Wis. Stat. ch. 343, that contains the photograph of the holder, an identification card issued under Wis. Stat. § 343.50 or an identification card issued under Wis. Stat. 1987 § 125.08.
(b) <u>Use</u>. No card other than the identification card authorized under this section may be recognized as an official identification card in this state. In place of an official identification card, documentary proof under Wis. Stat. § 125.07(7) may be substituted.

(c) No person may make, alter or duplicate an official identification card, provide an official identification card to an underage person or knowingly provide other documentation to an underage person purporting to show that the underage person has attained the legal drinking age. No person may possess an official identification card or other documentation used for proof of age with the intent of providing it to an underage person.

Section 2. That Section 400-6, <u>Issuance of Licenses</u>, is hereby amended as follows:

Add Thereto:

H. Class "B" License Requirements

- 1. The Class "B" licensed establishment must have a completely separate premises description from all other licensed establishments and comply with all relevant provisions of Wis. Stat. Ch. 125 and the Code of the City of Fond du Lac. The following requirements must be met before the license can be issued.
- 2. Separate premises must include the following:
 - a. The two businesses cannot permit cross access besides an emergency exit.
 - b. The two businesses must be completely walled off from one another.
 - c. Customers cannot easily go back and forth between the two businesses while consuming alcohol.
 - d. There ae separate outside entrances to each of the two businesses.
 - e. There are separate counters at each location that can specifically monitor the requirements of each separate license.
- The applicant must submit a site plan to the City of Fond du Lac Inspections Department showing said separate premises descriptions.
- 4. The property must pass all inspections with the City of Fond du Lac Inspections and Fire Departments and Fond du Lac County Health Department (when applicable), and obtain an occupancy permit.

Section 3. That Section 400-14, <u>"Class C" License</u>, is hereby amended as follows:

Add Thereto:

5. A "Class C" license authorizes the retail sale of wine by the glass or in an opened original container for consumption on the premises where sold. For establishments with two land uses, they are only available to the types of uses shown in Schedule I, see attached. For a Wine Bar, where there is only the land use of a drinking

establishment or restaurant that just serves wine, the closing hours may mirror those of a "Class B" or Class "B" license.

- a. A "Class C" license shall particularly describe the premises for which it is issued.
- b. The fee for a "Class C" license shall be as shown in the fee schedule.
- c. Operator's or Manager's License. An Operator's or Manager's license shall permit its holder to serve or sell alcohol beverages and is required for a Class C license.

6. Class C Hours.

(a) <u>Premises Hours</u>. No premises which is more than one land use for which a Class C alcohol beverage license shall have been issued shall be permitted to remain open for the sale or dispensing of alcohol beverages between the hours of 9:00 p.m. and 8:00 a.m. but shall be permitted to stay open for the conduct of their regular business.

(b) <u>Regulation of Closed Retail Space.</u> Only the permitted, licensee, employees, salespersons, employees of wholesalers licensed under Wis. Stat. § 125.28(1) or 125.54(1), or service personnel may be present on Class C premises during hours when the premises are not open for business if those persons are performing job-related activities. All other employees and patrons shall vacate the premises at 9:00 p.m.

7. Intoxicated Persons.

a. (a) Restrictions.

- No person may procure for, sell, dispense, or give away alcohol beverages to a person who is intoxicated.
 No licensee or permittee may sell, vend, deal or traffic in alcohol beverages to or with a person who is intoxicated.
 No licensee or permittee may permit an intoxicated person to be on a licensed premises.
- 8. Licensee/Operator under the Influence. It shall be unlawful for the licensee or any employee of a licensed establishment to be under the influence of an intoxicant, or a controlled substance or a combination of an intoxicant and a controlled substance, while performing services on the licensed premises.
- 9. Identification of Patrons 21 Years of Age and Older. Any licensed establishment that meets the exceptions contained in Section 125, Wisconsin Statutes and Chapter 400-1 of the Fond du Lac Code for allowing underage patrons on the licensed premise, must have a means of visually and conspicuously identifying patrons who are twenty-one (21) years of age and older. It shall be the sole responsibility of the license holder to determine whether any of the exceptions contained in

Wis. Stat. § 125, and Section 400-1, Fond du Lac Code, apply to their establishment.

- 10. **Control of Premises**. At no time may licensee relinquish control of the licensed premises or the service of alcohol to any other person or entity. The licensee must remain in control of the premises and must continue to be in control of the alcohol and service thereof through the licensee's own employees, including but not limited to checking identification of patrons, collecting money or tickets from patrons for drinks, or for charges for entry to the establishment or any area within the establishment, during all events, including private parties. The licensee and its employees will be held responsible for all conduct taking place on its premises at all times including conduct taking place during private parties. Notwithstanding the limitations of this subdivision, a licensee may contract with an agency that is licensed by the State of Wisconsin as a supplier of uniformed private security personnel to engage in private security activities.
- 11. Face-to-face Retail Sales. Except as provided in Wis. Stat. § 125.26(2m), 125.26(2s), 125.51(3)(bm) and 125.51(bs), and except with respect to caterers, a retail alcohol license issued under this chapter authorizes only face-to-face sales to consumers at the premises described in the retail license.
- 12. Wholesaler Source. No retail licensee shall purchase alcohol beverages from any source other than a licensed wholesaler, except as permitted by state law.
- 13. **Conditions on License**. A licensee shall comply with all conditions placed upon its license by action of the City Council.
- 14. Exceeding Lawful Occupancy Capacity.
 - a. (a) No licensee or person shall permit or allow occupancy of the licensed premise in excess of the lawfully established occupancy capacity. Occupancy capacity includes all staff and persons on the premise.

Section 4. Any person violating the provisions of this Ordinance shall be subject to the penalty provided in Section 1-4 of the Code.

<u>Section 5</u>. The appropriate City officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.

Section 6. All other ordinances and resolutions inconsistent with the provisions of this Ordinance are hereby repealed.

Section 7. This Ordinance shall take effect and be in force upon its passage and publication as provided by law.
